L.W. Paul Living History Farm Guidelines

- If a situation arises last minute, i.e. cancellation, late arrival, etc...please call the Farm as soon as you are aware of the delay 843-915-5321
- Cell phones use is not permitted during tours
- Students and visitors should dress prepared for outside conditions and walking on uneven ground
- Notify Museum as soon as possible if there are changes or cancelation of schedule.
- Allow a minimum of 2 hours in your schedule from arrival to departure.
- Instruct students about safety before arrival.
- All students must stay with group at all times. There must be at least 1 adult chaperone with each group at all times.
- 8 picnic tables are available for students if you wish to have lunch at the farm. You may need to bring picnic blankets or towels to seat the other children outside. Eating lunch in the gift shop is not permitted for group tours. The farm does not prepare food for lunches.

Information about the L.W. Paul Living History Farm

In 2007, Larry Paul approached the Horry County Museum with a large collection of artifacts that related the story of his past. Farm implements, wagons, household tools, woodstoves, and kitchen utensils from the period spanning 1900 to 1955 made up the majority of his collection. Larry's goal was to donate these artifacts to the museum to be preserved for future generations to enjoy and learn from. It had become painfully clear that in his generation the typical family farm he grew up on had been lost to history. Today no one lives on self-sufficient small farms anymore and that element of local culture is gone.

Larry and Museum staff began working on plans to take the items from his collections and put them in a living history farm environment so that the public could see, smell, feel and taste what life on a small farm in the first half of the twentieth century was like in Horry County. The idea met with County Council approval and planning began on the living history project.

The L.W. Paul Living History Farm was built by Larry Paul as a gift to Horry County. It is the Museum's goal to recreate what life was like on the typical family farm and share these experiences with the public through interpretive displays, demonstrations, and programs. Visitors are invited into the visitor's center where they are greeted with a gift shop area featuring local books, traditional crafts, snacks, and restrooms. The farm has been built to show two historical elements of the farming culture. One route will take a visitor to see buildings and structures that were typical of all farming communities including the syrup shed and cane mill, grits mill, wood working shop, blacksmith shop, sawmill and chapel. Demonstrations and events take place in these shops seasonally and during monthly events. The other route will take the visitor to the one horse family farm that includes a farmhouse, smoke house, outhouse, pack house, livestock, tobacco barn, and row crops. Daily activities take place here as they would on any working farm during this time period. The fields are worked with a mule, the smoke house is kept full of arm cured meat, meals are cooked on the wood stove and eggs are collected from the chickens.

Visitors are invited to witness many of the activities that take place on the farm during seasonal events and demonstrations. Call the L.W. Paul Living History Farm for details concerning tours and events. Farm hours are 9:00 am to 4:00 pm Tuesday – Saturday. Admission is free but we do accept donations. The Farm is located at 2279 Harris Short Cut Road on the corner of Harris Shortcut Road and Hwy 701 North in Conway, SC.
